Personal data that we process

Centipede processes your personal data if you are using our services and / or if you provide it to us yourself.

Below is an overview of the personal data we process:

- First and last name
- Sex
- Address data
- Phone number
- E-mail address
- Bank account number

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years old. Unless they have permission from parents or guardians. However, we can not check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. For what purpose and on what basis we process personal data

Centipede processes your personal data for the following purposes:

- Handling your payment
- To call or e-mail you if necessary to carry out our services
- To deliver goods and services to you
- Centipede also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision-making

Centipede does not make decisions based on automated processing about matters that can have (significant) consequences for individuals. These are decisions that are taken by computer programs or systems, without involving a person (for example, an employee of Centipede).

How long we store personal data

Centipede does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

Sharing personal data with third parties

Centipede will not sell your information to third parties and will only provide this information if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Centipede remains responsible for these processing operations.

Cookies, or similar techniques, that we use

Centipede does not use cookies or similar techniques.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Centipede and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data via jeroen_advocaat@hotmail.com. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request. Centipede also wishes to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
